Mr C. Denne, the applicant, spoke in support of the application A11/1643 – 76, South Street - Variation of Condition to change the hours of opening. He said that much of the current noise was caused by the alteration work. It was a "commercial" terrace and the requested hours were needed to run the cafe.
