Min 29. Review of Town Centre Traffic Changes and Options for South Street – Process Report

It was asked if a meeting of the Town Hall and Bucky Doo Working Party could be arranged, to discuss options for Bucky Doo Square.

RESOLVED: that a detailed report on the process for a review of the town centre traffic management changes, including the options for South Street and consultation proposals, be considered in the Summer of 2013.

Min 32. West Dorset District Council Parking Charges Consultation 2013/14

RESOLVED: that there be no objections to the following proposals:

- (1) To freeze the scale of charges in West Dorset District Council car parks for a further twelve months, and
- (2) To withdraw the 3-8 day permit scheme.

92. MILES CROSS REPORT BACK

93. DCC STATEMENT OF COMMUNITY INVOLVEMENT

Consideration was given to a report of the Town Clerk, ENCL: 2650. Members made the following comments:

- consultation exercises should be as open as possible, with people having the opportunity to put forward proposals and influence the process.
- consultation should take place as early as possible and in all cases allow sufficient time for responses.
- the part of the Dorsetforyou web site, where the County Council planning applications can be viewed, was not as easy to use and locate documents as the main DorsetforYou planning application section. It was felt that the County Council applications should be published in the same way and on the same part of DorsetforYou, as the District applications.
- the attendance of County Council officers at local meetings would be helpful, when it was felt to be necessary.

RESOLVED: that the Town Clerk, in consultation with the Chairman of the Committee, be given delegated authority to respond to this consultation, based on the comments as set out above.

94. BUS SERVICES COUNTY COUNCIL WORKSHOP

RESOLVED: that Cllr Ms S.J. Williams be appointed as the Town Council representative to attend a workshop on bus services in the area, on 13 February 2013 at 10.00am at the Dorford Centre, Dorchester.

95. STREET NAMING AND NUMBERING

RESOLVED: that the five houses off Folly Mill Lane be numbered 1-5, Folly Mill Mews.

96. <u>COMMUNICATIONS</u>
