#### ANNUAL GOVERNANCE AND ACCOUNTABILITY RETURN

### REPORT OF THE TOWN CLERK

#### 1.0 PURPOSE

1.1 This report asks the Council to formally approve the Annual Governance and Accountability Return for 2018/2019 (Sections 1 and 2 at Appendix 1). **The Town Council must separately approve both of these sections in order.** 

### 2.0 BACKGROUND

- 2.1 Each smaller authority is required by law
  - to prepare Accounting Statements for the year ended 31 March 2019 in the form required by proper practices (the relevant annual return, now known as the Annual Governance and Accountability Return or AGAR, Part 3 applies to the Town Council);
  - to approve and publish the AGAR including the Accounting Statements
  - to provide for the exercise of public rights; and
  - to publish the AGAR, including the signed external auditor report, by 30 September 2019.
- 2.2 Section 1, Annual Governance Statement, confirms the controls that are in place in respect of all aspects of the governance of the Council. This includes the preparation of the accounts, risk assessments etc.
- 2.3 Section 2 of the Annual Return is the Accounting Statements, prepared by the Town Council. The figures in the Statement are as in the Annual Accounts, as reported to the Finance and General Purposes Committee, for consideration on 10 June 2019. The Council's Internal Auditors have checked the calculations in Section 2.
- 2.4 Prior to approving Section 1 and then Section 2, the Town Council must note the Annual Internal Auditor Report, in which they have assessed the Council's compliance with relevant procedures and controls. This is attached.
- 2.5 Section 3 of the Statement, which is not attached, is completed by the Town Council's External Auditor, PKF Littlejohn, when they have completed the audit.
- 2.6 The Town Council is required to approve the Annual Governance Statement and Annual Accounting Statements by 1 July 2019, to then be forwarded with supporting papers to the Council's External Auditor.

### 3.0 RECOMMENDATIONS

The Town Council is recommended to note the Annual Internal Auditor Report and then separately approve the Annual Governance Statement and Accounting Statements for 2018/2019, all as attached.

## Annual Governance and Accountability Return 2018/19 Part 3

# To be completed by Local Councils, Internal Drainage Boards and other Smaller Authorities\*:

- where the higher of gross income or gross expenditure exceeded £25,000 but did not exceed £6.5 million; or
- where the higher of gross income or gross expenditure was £25,000 or less but:

# Guidance notes on completing Part 3 of the Annual Governance and Accountability Return 2018/19

- Every smaller authority in England that either received gross income or incurred gross expenditure exceeding £25,000 must complete Part 3 of the Annual Governance and Accountability Return at the end of each financial year in accordance with Proper Practices.
- 2. The Annual Governance and Accountability Return is made up of three parts, pages 3 to 6:
  - . The annual internal audit report is completed by the authority's internal auditor.
  - Sections 1 and 2 are to be completed and approved by the authority.
  - · Section 3 is completed by the external auditor and will be returned to the authority.
- The authority must approve Section 1, Annual Governance Statement, before approving Section 2, Accounting Statements, and both must be approved and published before 1 July 2019.
- 4. An authority with either gross income or gross expenditure exceeding £25,000 or an authority with neither income nor expenditure exceeding £25,000, but which is unable to certify itself as exempt, or is requesting a limited assurance review, must return to the external auditor by email or post (not both):
  - · the Annual Governance and Accountability Return Sections 1 and 2, together with
  - · a bank reconciliation as at 31 March 2019
  - · an explanation of any significant year on year variances in the accounting statements
  - · notification of the commencement date of the period for the exercise of public rights
  - Annual Internal Audit Report 2018/19

Unless requested, do not send any additional documents to your external auditor. Your external auditor will ask for any additional documents needed.

Once the external auditor has completed the review and is able to give an opinion on the limited assurance review, the Annual Governance and Accountability Section1, Section 2 and Section 3 – External Auditor Report and Certificate will be returned to the authority by email or post.

#### **Publication Requirements**

Under the Accounts and Audit Regulations 2015, authorities must publish the following information on a publicly accessible website:

Before 1 July 2019 authorities must publish:

- Notice of the period for the exercise of public rights and a declaration that the accounting statements are as yet unaudited;
- Section 1 Annual Governance Statement 2018/19, approved and signed, page 4
- Section 2 Accounting Statements 2018/19, approved and signed, page 5

Not later than 30 September 2019 authorities must publish:

- · Notice of conclusion of audit
- Section 3 External Auditor Report and Certificate
- Sections 1 & 2 of AGAR including any amendments as a result of the limited assurance review.

It is recommended as best practice, to avoid any potential confusion by local electors and interested parties, that you also publish the Annual Internal Audit Report, page 3.

The Annual Governance and Accountability Return constitutes the annual return referred to in the Accounts and Audit Regulations 2015. Throughout, the words 'external auditor' have the same meaning as the words 'local auditor' in the Accounts and Audit Regulations 2015.

# Guidance notes on completing Part 3 of the Annual Governance and Accountability Return 2018/19

- The authority must comply with Proper Practices in completing Sections 1 and 2 of this Annual Governance and Accountability Return. Proper Practices are found in the Practitioners' Guide\* which is updated from time to time and contains everything needed to prepare successfully for the financial year-end and the subsequent work by the external auditor.
- Make sure that the Annual Governance and Accountability Return is complete (i.e. no empty highlighted boxes), and is properly signed and dated. Where amendments are made by the authority to the AGAR after it has been approved by the authority and before it has been reviewed by the external auditor, the Chairman and RFO should initial the amendments and if necessary republish the amended AGAR and recommence the period for the exercise of public rights. If the Annual Governance and Accountability Return contains unapproved or unexplained amendments, it may be returned and additional costs will be incurred.
- The authority should receive and note the annual internal audit report if possible prior to approving the annual
  governance statement and before approving the accounts.
- Use the checklist provided below to review the Annual Governance and Accountability Return for completeness before returning it to the external auditor by email or post (not both).
- Do not send the external auditor any information not specifically requested. However, you must inform your
  external auditor about any change of Clerk, Responsible Financial Officer or Chairman, and provide
  relevant email addresses and telephone numbers.
- Make sure that the copy of the bank reconciliation to be sent to your external auditor with the Annual Governance
  and Accountability Return covers all the bank accounts. If the authority holds any short-term investments, note their
  value on the bank reconciliation. The external auditor must be able to agree the bank reconciliation to Box 8 on the
  accounting statements (Section 2, page 5). An explanation must be provided of any difference between Box 7 and
  Box 8. More help on bank reconciliation is available in the Practitioners' Guide\*.
- Explain fully significant variances in the accounting statements on page 5. Do not just send a copy of the detailed
  accounting records instead of this explanation. The external auditor wants to know that you understand the reasons
  for all variances. Include complete numerical and narrative analysis to support the full variance.
- If the external auditor has to review unsolicited information, or receives an incomplete bank reconciliation, or variances are not fully explained, additional costs may be incurred.
- Make sure that the accounting statements add up and that the balance carried forward from the previous year (Box 7 of 2018) equals the balance brought forward in the current year (Box 1 of 2019).
- The Responsible Financial Officer (RFO), on behalf of the authority, must set the period for the exercise of public
  rights. From the commencement date for a single period of 30 consecutive working days, the approved accounts
  and accounting records can be inspected. Whatever period the RFO sets it must include a common inspection
  period during which the accounts and accounting records of all smaller authorities must be available for public
  inspection of the first ten working days of July.
- The authority must publish the information required by Regulation 15 (2), Accounts and Audit Regulations 2015, including the period for the exercise of public rights and the name and address of the external auditor before 1 July 2019.
