### **PUBLIC FORUM**

Mr J Tigg addressed members regarding planning applications 1/D/11/002012 and WD/D/16/002852, relating to St Michael's Trading Estate. He commented that:

- the rooms in the Stover building appeared to meet minimum size standards;
- viability studies had shown 22, then 14, then 7 homes to be affordable;
- there was no indication of the size of the affordable homes;
- the applicant should plan for the full amount of affordable housing, to demonstrate blind tenure;
- the Neighbourhood Plan stipulates that new houses for open market sale are not required; and
- both applications looked reasonable.

The Chairman thanked Mr Tigg for his address.
